Tony Wise Birkie Spirit Award to David Nelson

A major highlight at our Awards Breakfast the last two years has been the presentation of the Tony Wise Birkie Spirit Award. We had the pleasure of honoring three special individuals, Sven Wiik, Marty Hall and Frances Wise. This time, I am delighted to announce the 2012 recipient, David Nelson. David is our fellow Birchlegger, serves on the ABSF board of directors, but is most famous for his talent in designing, building and promoting cross country ski trails. If you have been enjoying the new Birkie Classic Trail, you can thank David for its existence.

Birchleggers Hut at Mosquito Brook Road built and open for use.

In 2010, Executive Director Ned Zuelsdorff proposed a plan to construct several buildings along the Birkie trail for storage of some of the equipment needed during the race and other Birkie sponsored events. The plan was approved by the board of directors and the concept was expanded to use a portion of some of the structures as warming cabins. The first modest structure was built last year at the intersection with the Bodecker Road. Since the main funding for these structures was to be obtained by soliciting sponsorships, the Birchleggings Club saw the opportunity to contribute and also to put its name on a visible object. It was agreed that the next cabin to be built at the Mosquito Brook Road would be fully funded by the Club and would be named "The Birchleggers Hut". A fellow skier and architect Terry Penman was retained to develop the plan with emphasis on aesthetics. The hut is larger than the one at Bodecker road and the warming hut portion is larger than the storage section. The finishing touches are still going on but it has a wood stove and is ready to use. Check it out next time you ski in the area. We

are now looking for a design of an attractive and very visible sign to show off our name and logo. The hut, of course, is open to all. It is our gift to the skiing community, but we will have every opportunity to equip and decorate the interior as we like. I see a great potential here - Ideas?

More Founder-like, red racing bibs to be seen on the Trail this year.



There once were ten individuals wearing the red "Founder" bib in the race (the ten who completed the first ten consecutive Birkebeiners). These ten individuals, over the years, came to symbolically commemorate the roots of the event and inspire younger skiers to keep returning to the race and help to maintain a strong tradition. Inevitably, over forty years, these numbers have shrunk. Many skiers have expressed the value of these bibs to the race. Over a beer one evening, a fellow board member and Birchlegger John Leighton and I brainstormed ways to perpetuate the presence of the red bibs. We guickly came up with the idea of printing a limited number of bibs to be worn by those with the most Birkie completions. The next question was "how many"? Thinking of my fellow founders, my mind quickly reached into 1973 and I realized there were only 35 skiers in the first race, so why not commemorate all of them--35 red bibs. Now, what inscription should replace "founder"? This took a little more brainstorming. Driving home from our cabin one day, my wife Nina and 13 year-old daughter Katie worked on the task. We had the number 35 to work with, but it was hard to come up with a supporting word or short phrase. Then our minds turned to our fellow founder David Landgraf, just lost to a tragic accident. We could still hear Dave's favorite song that was played at his memorial services: Spirit in the Sky. We tossed around the word "spirit" for a while and then Katie came up with "Spirit of Thirtyfive". It was perfect, no need for further search. The Birkie Board of Directors unanimously accepted the proposal. (Note: Final selection of who gets to wear a red bib is based on order of completion of the greatest number--so keep up with your training!)

Status of Birchleggings Club incorporation as a 501(c) corporation

The volunteer Birchleggings Club steering committee met in Cable last Fall to discuss the incorporation process. The application process for incorporation is rather simple, however documentation to qualify for tax-exempt status is a bit more involved. I have been looking for a volunteer attorney from our club to give us some guidance. If you have expertise in this area, please contact me. We hope to move aggressively on this again as soon as we put this year's Birkie behind us. We will keep you informed through our web site.

Paying your membership dues is crucial to the functioning of your club.

Annual membership dues are our only source of funding for our projects. The funds are used to produce awards, contribute to TW Legacy Fund and cover Awards Breakfast costs for new members. Now we have added a major funding project, The Birchleggers Hut. We will be discussing additional fund raising options to help with this item.
